	<p>ON THE ABOVE DATE AND TIME, I OFFICER WILLIAMS WAS DISPATCHED TO 1320 CELEBRITY CIR "BATB SECURITY OFFICE" FOR A TRESPASSING INCIDENT. LT. DOYLE "SECURITY OFFICER" SAID THAT HE RESPONDED TO AN INCIDENT IN FRONT OF CROCODILE ROCKS WHERE MARK MCBRIDE WAS HOLDING A PRIVATE PARTY. SUBJECT "GREEN" WAS TRYING TO ENTER CROCODILE ROCKS WHEN THE OWNER OF THE ESTABLISHMENT TOLD HIM THAT IT WAS IN HIS BEST INTEREST NOT TO ENTER THE BAR, AT WHICH POINT A ALTERCATION TOOK PLACE IN FRONT OF THE DOOR. LT DOYLE SAID THAT HE TOLD SUBJ. "GREEN" TO LEAVE PROPERTY NUMEROUS TIMES. HE REFUSED AND TRIED TO WALK AWAY FROM HIM. LT. DOYLE SAID HE TOLD GREEN THAT HE WAS TRESPASSING AND GREEN STILL REFUSED TO LEAVE THE PROPERTY AGAIN. GREEN WAS DETAINED AND WAS CHARGE WITH TRESPASSING. HE WAS TRANSPORTED TO THE JAIL.</p> <p>SUBJ.
